

**MINUTES OF THE  
FERNLEY CITY COUNCIL MEETING  
JULY 18, 2018**

Mayor Edgington called the meeting to order at 5:01 pm at Fernley City Hall, 595 Silver Lace Blvd, Fernley, NV.

**1. INTRODUCTORY ITEMS**

Mayor Edgington read the Lyon County Sheriff's Office monthly call report for June into the record.

City Manager Hooper announced the groundbreaking for Polari's on August 9<sup>th</sup> at 9:30 a.m. on site. She also reminded everyone of the Master Plan Workshop on July 25<sup>th</sup> at 5:00 p.m.

Planning Director Thompson reviewed the applications the department received. He stated the final draft for the Master Plan will be heard by the Planning Commission on August 8<sup>th</sup>.

Councilwoman Fran McKay reported the Relay for Life event went well. She also attended the Northern Nevada Business Weekly Monthly Meeting.

Councilwoman Whalen reported Mayor Edgington as well as other City delegates took a field trip and looked at different housing types being built in other cities in preparation for the Master Plan Workshop. She felt it was an informative and productive day. Councilwoman Whalen thanked staff for their work on Cedar Street.

Mayor Edgington reported the field trip for different housing types was very informative.

## 5. PRESENTATIONS

### 5.1. Discussion and possible action to approve Resolution 18-010, providing for the transfer of the City's 2018 Private Activity Bond Volume Cap to the Nevada Rural Housing Authority.

Diane Arvizo, Director of Home Ownership Programs with Nevada Rural Housing Authority presented an overview of an exclusive program for homeowners in the rural areas. Ms. Arvizo shared the program started with two option programs and now there are 20 of programs available. Ms. Arvizo announced the program has assisted more than 7,400 families, which 437 are families in Fernley.

## 6. PUBLIC HEARING

### 6.1 Public Hearing, RA 2018-001

**Consideration and possible approval of a request to abandon a portion of a public right-of-way, identified as Wild Flower Lane as shown on the Official Plat of Silverland Estates Phase 2, filed in the Office of the County Recorder of Lyon County, State of Nevada, on March 2, 2006, as Document Number 376480, Official Records, APN (s): 022-402-02, 03, 022-403-01, 02, and 03.**

Assistant Planner Melinda Bauer presented the request to abandon a portion of a public right-of-way, identified as Wild Flower Lane. The proposed right-of-way abandonment is not necessary to provide access to adjacent parcels. Ms. Bauer stated the applicant also submitted a merger and re-subdivision of lots 13-17, creating three (3) parcels. She asked City Staff to recommend the approval of the public right-of-way abandonment request.

Councilwoman Seidl asked City staff to notify the Department of Taxation with Lyon County of the abandonment. Planning Director Tim Thompson explained the process of the abandonment will be recorded with Lyon County Assessor's Office.

Mayor Edgington called for public comment.

There were none.

## 6.2 Public Hearing, RTA 2018-001

**Consideration and Possible Action to approve a Reversion to Acreage map to combine two parcels, one parcel ± 15.17 acres and one ± 1.71 acres, creating one parcel approximately 16.88 acres in size in the NR-2 zoning district located at 610 and 660 Westerlund Lane, Fernley, NV (APN(s): 021-103-45 & 14).**

Assistant Planner Melinda Bauer presented the request to merge two parcels, 610 Westerlund Lane and 660 Westerlund Lane. She explained on February 21, 2018 there was a zone change on 660 Westerlund Lane from RR-1 (Rural Residential, 1 Acre Minimum Parcel Size) to NR-2 (Multiple Residence 8,000 SF) and the land use classification from Residential High Density to Residential Multi-Family bringing both the zoning and land use into conformance with 610 Westerlund Lane. Ms. Bauer stated the two parcels are part of a proposed apartment complex. Staff is recommending the approval of the Reversion to Acreage, RTA 2018-001, Bauer stated.

Nathan Robison, Civil Engineer was available for questions. Mayor Edgington called for public input. There was none.

## 7. STAFF REPORTS

### **7.1. Discussion and Possible Action on the Hearing of Revocation for BL17-5371 issued to Federal National Mortgage Association pursuant to Fernley Municipal Code 10.01.19 Denial, probation, suspension, revocation of standard business license; grounds; procedure; immediate suspension; cease and desist orders.**

City Clerk Kim Swanson presented the evidence for the revocation against Clarence Moses Willis. She outlined the Fernley Municipal Code for each violation and provided the supporting information. Ms. Swanson recommended that City Council approve the revocation against Mr. Willis.

Mayor Edgington asked City Clerk Swanson to notify the State of Nevada Business License Division regarding this revocation.

### **7.2. Introduction Bill #267, ZMA 2018-002**

**First Reading Consideration and possible action to introduce Bill # 267, an Ordinance for a zoning map amendment request from Fernley Swimming Pool District to change the zoning from NR-1 (Single-Family 6,000 SF) to PF (Public Facility) on a site ± 4.97 acres in size located at 300 Cottonwood Lane, Fernley, NV. (APN: 021-131-10).**

Assistant Planner Melinda Bauer presented Bill #267, ZMA 2018-002 a request from the Fernley Swimming Pool District. Currently, the parcel has a designation as NR-1 (Single-Family 6,000 SF) and the comprehensive land is PF (Public Facility). Ms. Bauer stated changing the zoning would bring the parcel into conformance with the land use designation of Public Facilities. The public facility use is considered compatible with all adjacent land uses, Bauer stated. Ms. Bauer reported at the Planning Commission Board Meeting on June 13<sup>th</sup>, ZMA 2018-002 was approved by the board.

Manager Daphne Hooper stated the City Council will soon hear an item regarding the council room sound upgrade.


**ADJOURNMENT**
