BUSINESS LICENSE FEE SCHEDULE
 Exhibit "A"
 Effective January 1, 2017

Pursuant to Fernley Municipal Code, any business, commercial enterprise, trade, occupation, calling, profession, vocation, or activity engaged in, conducted, carried on by any person, his agent or employee in an attempt and with the intent to gain business for profit or having conducted business within the City of Fernley shall be required to obtain a business license and pay the following fees:

Application Fee

Every business shall pay the non-refundable application fee. \$ 25.00

Reprint/Change of Information Fee

\$ 15.00

Late Fees

Fees are expected to be paid immediately upon application. Renewal fees are required to be paid prior to the license expiration date. Failure to pay these fees will result in late fees as follows:

1. A late fee of 25% will be assessed to the annual fee on the 30th day following the expiration date.
2. An additional late fee of 25% will be assessed to the delinquent license fee on the 60th day following the expiration date.

Background Investigation Fees are set by the authorized agency conducting the investigations.

Annual Gross Receipts Business License Fee Schedule:

Pursuant to Fernley Municipal Code, all businesses or individuals, with a physical address within the City of Fernley, who provides a service or sells physical products as an industrial, retail or commercial business office within City limits with the intent and in an attempt to gain business in the City of Fernley are subject to their annual business license fees being calculated using the gross receipts fee schedule.

Contractors that use their home as their office shall pay business license fees according to gross receipts earned in Fernley only.

If your business is subject to Gross Receipts per Fernley Municipal Code your business license fees are as follows:

1. New businesses securing a license under the gross receipts fee schedule will pay license fees based on the first 12 months estimated gross receipts, in addition to the \$25 application fee above.
2. For no additional fee, businesses whose annual license fees exceed \$10,000 per fiscal year may request to pay license fees quarterly.

0 - \$250,000	\$100.00
\$250,000 - \$400,000	\$275.00
Over \$400,000	\$300 + \$1 for every \$10,000

Businesses Subject to Gross Receipts:

The following businesses shall be subject to the gross receipts fees above **plus** the additional fees listed below, in addition to the \$25 application fee if applicable.

1. Specialty Licenses

Specialty Licenses shall be charged according to the Annual Gross Receipts Fee Schedule, in addition to the annual fees listed below. Specialty Licenses shall also be subject to a background investigation and shall pay the required fees.

(A) Auto Pawn:

Shall be charged according to the Annual Gross Receipts Fee Schedule plus Annual Fee of: \$ 500.00

(B) Pawnbrokers:

Shall be charged according to the Annual Gross Receipts Fee Schedule plus Annual Fee of: \$ 500.00

(C) Check Cashing Service/Payday Loan:

Shall be charged according to the Annual Gross Receipts Fee Schedule plus an Annual Fee of: \$ 200.00

(D) Second Hand Dealer:

Shall be charged according to the Annual Gross Receipts Fee Schedule plus an Annual Fee of: \$ 200.00

(E) Sexually Oriented Businesses:

All businesses in this category will pay a onetime set up fee of: \$ 4,000.00

- I. **Brothels:** Shall pay according to the Annual Gross Receipts Fee Schedule plus an Annual Fee of:

1-10 \$ 48,000.00
11-20 \$ 60,000.00

- II. **Entertainers/Independent Contractors** Shall pay for a separate business license using the Annual Gross Receipts Fee Schedule.

- III. **Adult Movie Theaters:** Shall pay according to the Annual Gross Receipts Fee Schedule plus an Annual Fee of: \$ 1,600.00

- IV. **Topless Bar:** Shall pay according to the Annual Gross Receipts Fee Schedule plus an Annual Fee of: \$ 1,600.00

2. Title Loan:

Shall be charged according to the Annual Gross Receipts Fee Schedule plus an Annual Fee of: \$ 500.00

3. Kennel

Commercial locations shall pay according to the Annual Gross Receipts Fee Schedule plus an annual fee of: \$ 50.00

4. Home Based Contractors

Shall pay according to the Annual Gross Receipts Fee Schedule for projects in the City of Fernley.

5. Mobile Vendors – Annual Fee \$ 80.00

Shall be charged according to the Gross Receipts Fee Schedule over \$30,000

Exempt from Gross Receipts

The following businesses shall NOT be subject to the gross receipts fees listed above and shall be charged fees as follows. These fees are in addition to the application fee noted above:

Apartment Houses – Annual Fee- Include all units

Up to 20	\$ 100.00
21 – 30	\$ 200.00
31 – 50	\$ 300.00
51 – 100	\$ 500.00
101- 150	\$ 1,000.00
151-300	\$ 1,500.00
Each unit over 300	\$ 15.00/per unit

Financial Institutions

Shall pay an Annual Fee of: \$ 100.00
Plus \$60 per one million dollars or total average deposits per year or fraction thereof, per branch.

Beginning with the first \$15 for each line of access for each of the utility's customers located within the City.
